Dear Prospective Exhibitor:

In an effort to promote area home and horticulture business, and to provide educational opportunities, the Harvey County Master Gardeners are hosting the annual Harvey County Home and Garden Show [HCH&GS]. The dates are scheduled for Saturday, March 16 from 8:30 a.m. – 5 p.m. and Sunday, March 17 from Noon – 5 p.m.

This event will be in the National Guard Armory at 400 Grandview in Newton. The show theme is “***Creative Container Gardening.***”

Again this year we will have an activity for youth to participate in.

This is prime time for planting and home remodeling and will make a great event. Speakers, both local and statewide, are confirmed for the educational seminars and sponsors have been secured for the show.

In addition to local and state advertising for the show, a website will give detailed information. All participants will be listed and links provided, if they have their own website. In order to include your business information, we must receive your registration no later than **March 4th**.

This year we will offer two booth sizes. The smaller booth size (8' x 8') costs \$20 per space (limit 2). The larger booth size (10' x 10') is an affordable \$30 (limit 2). If you would like electricity there is an additional fee of \$5 per booth. After March 4, the fee will be \$30 and \$40 per booth space. Please see the enclosed registration form. **Your booths must be staffed from open to close, both days of the show.** Admission fee includes all educational seminars. To help beautify the show, we ask that you include at least **three square feet** of living plant material in your booth.

The Harvey County Extension Service, Master Gardeners Volunteers and the National Guard Armory are not responsible for damage, lost/missing/stolen items or for accidents. We encourage exhibitors to have liability insurance. If you have further questions, please call me at (316) 284-6930.
